BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of EMERALD HILLS JOINT VENTURE, a joint venture composed of WILLIAMSON PARK CO., a California corporation, Joint Venturer, and SWAN CONSTRUCTORS, INC., a California corporation, Joint Venturer; and WILLIAMSON PARK CO., a California corporation, executed in favor of The City of San Diego, bearing date April 14, 1971, conveying to said City a portion of Lot 18 of the Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Partition Map thereof made in an action entitled, "Juan M.
