That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City, a preferential nonexclusive use and occupancy permit granting permission to the PACIFIC BEACH TOWN COUNCIL, INC. to use and occupy those certain premises known as Mission Bay Park Tract, Portion Blocks B & D, for a period of one year and one month beginning on June 1, 1971 and ending June 30, 1972, for the purpose of using said premises as an outdoor sports area for youth athletic and recreational activities, under the terms and conditions set forth in the form of preferential nonexclusive use and occupancy permit on file in the office of the City Clerk as Document No. 736240.
