APPROVING MAP OF CEDARBRAE RESUBDIVISION NO. 1

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled "CEDARBRAE RESUBDIVISION NO. 1 Being a subdivision of Lot 3 in Cedarbrae, together with a portion of Cedarbrae Lane, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 4222, filed in the office of the County Recorder, June 11, 1959.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Aztec Street, adjacent and contiguous to Lots 1 and 2, as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map  
to the Clerk of the Board of Supervisors of the County of  
San Diego, California.
