

RESOLUTION NO. 202978

WHEREAS, The City of San Diego is desirous of acquiring an easement for walkway purposes affecting a portion of Lot 222, Clairemont Mesa North Unit No. 5, according to Map thereof No. 6057, filed March 8, 1968, in the office of the San Diego County Recorder; and

WHEREAS, the owners of said portion of Lot 222 are willing to convey said easement to the City in exchange for a quitclaim deed from the City, quitclaiming an existing easement for walkway purposes affecting a portion of Lot 222, Clairemont Mesa North Unit No. 5; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; and

WHEREAS, the value of the property rights to be exchanged are equal, as determined by a staff appraiser, being the sum of \$100.00 each; and

WHEREAS, it is in the public interest that said exchange be made, and the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City

of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No.

736265, quitclaiming to THE OWNERS IN FEE SIMPLE OF RECORD, an existing easement for walkway purposes affecting a portion of Lot 222, Clairemont Mesa North Unit NO. 5, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
