BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the offers of 1. Neptune Meter Co. 2. Badger Meter Mfg. Co. 3. Gamon-Calmet Industries, Inc. 4. Hersey Products Inc. and 5. Rockwell Manufacturing Co. is hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of METER PARTS as may be required for a period of six months beginning July 1, 1971 through December 31, 1971 per prices on file in the Purchasing Department as follows:

1. Neptune Meter Co. parts discount 10% from list price; terms net 30 days plus sales tax.
2. Badger Meter Mfg. Co. parts discount Disc Meter 35% from list, compound meters 8% from list price; terms net 30 days, plus sales tax.
3. Gamon-Calmet Industries, Inc. parts discount 15% from list price; terms net 30 days, plus sales tax.
4. Hersey Products Inc. parts discount 25% from list price; terms net 30 days, plus sales tax.
5. Rockwell Mfg. Co. parts discount 15% from list price; terms net 30 days plus sales tax.
