BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$512,888.00 by C. W. McGrath, Inc., A Corporation, for THE CONSTRUCTION FOR THE SAN DIEGO WILD ANIMAL PARK ACCESS ROAD, PARKING LOT, VILLAGE GRADING, including Items 1 and 2 of Additive Alternate No. 1, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 735940.
2. That the expenditure of \$540,000 is hereby authorized out of the Bond Fund (731) of the City of San Diego solely and exclusively for the purpose of providing funds for THE CONSTRUCTION FOR THE SAN DIEGO WILD ANIMAL PARK ACCESS ROAD, PARKING LOT, VILLAGE GRADING, including Items 1 and 2 of Additive Alternate No. 1, in the City of San Diego, and related costs.
