

RESOLUTION NO. 203047

WHEREAS, The City of San Diego desires to undertake a program of Police Legal Advisor to the Police Department to be funded in part from funds made available through the Omnibus Crime Control and Safe Streets Act of 1968 administered by the California Council on Criminal Justice; and

WHEREAS, the City Council in Resolution No. 202306 dated March 30, 1971, authorized the City Manager to file an application for a grant for this purpose; and

WHEREAS, the California Council on Criminal Justice has approved the grant; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That as the California Council on Criminal Justice has consented to fund the above project, The City of San Diego agrees to accept the grant and the City Manager is hereby authorized to execute on behalf of The City of San Diego the contract for the grant for law enforcement purposes on file in the office of the City Clerk as Document No. 736508.

BE IT FURTHER RESOLVED, that The City of San Diego agrees to provide the required matching funds to said project.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.
