1. 2. That the expenditure of \$85,000.00 is hereby authorized out of the Park and Recreation Bond Fund (725) of the City of San Diego solely and exclusively for the purpose of providing funds for construction of PACIFIC BEACH ATHLETIC CENTER ADDITIONAL IMPROVEMENTS (Base Bid including Additive Alternate No. 1) in the City of San Diego, and related costs.
