

RESOLUTION NO. 203063 JUL 1 1971

APPROVING MAP OF RANCHO DOMINGO SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by PETER A. HATLEM, Registered Civil Engineer, and entitled, "RANCHO DOMINGO Being a subdivision of the Northwest Quarter of Lot 64 and the Northeast Quarter of Lot 65 of a portion of The Rancho Mission of San Diego, commonly known as Horton's Purchase, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 283 filed in the office of the County Recorder of San Diego County, March 9, 1878. Excepting from said Lot 65 that portion which lies within National Vista No. 2, according to Map thereof No. 2759, filed in the office of the County Recorder of San Diego County, March 9, 1951.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portion of public street, to wit: Magnus Way, Wyconda Lane, Wystone Drive, Privado Place, Wyconda Way and a portion of 50th Street, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the

easements with the right of ingress and egress for the construction and maintenance of sewer, slopes and drainage facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer, slopes and drainage facilities as granted and shown on this map within subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
