That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Lease Agreement with SLOOP & WITMAN, as lessee, amending that certain Lease Agreement between the parties which is on file in the office of the City Clerk as Document No. 694595, as amended, for the leasing of City-owned land in San Pasqual Valley to (1) add ten (10) acres to the leased premises and (2) increase the minimum annual rent from \$6,000.00 to \$6,500.00, under the terms and conditions set forth in the form of Second Amendment to Lease Agreement, on file in the office of the City Clerk as Document No. 736430.
