

RESOLUTION NO. 203072 JUL 1 1971

WHEREAS, a substantial portion of the land within the boundaries of the San Pasqual Union School District in the City of San Diego is owned by The City of San Diego and is largely occupied by tenants of the City holding long-term leases; and

WHEREAS, the leasehold interest of such tenants do not supply a sufficient tax base for revenue needed by said School District to sustain its services to the area so occupied; and

WHEREAS, the City Manager has recommended that the City make up a portion of the District's revenue deficiency attributable to City ownership of said land by paying to the School District a portion of rental receipts as hereinafter provided; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$991.25 from Water Operating Fund 500 for payment to the San Pasqual Union School District for services rendered to City tenants residing within the District during the 1970-71 school year be, and it is hereby authorized.
