APPROVING MAP OF PENASQUITOS GLENS UNIT NO. 4 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS E. CRAIG, Registered Civil Engineer, and entitled, "PENASQUITOS GLENS UNIT NO. 4 Being a subdivision of a portion of Section 33, Township 13 South, Range 2 West, San Bernardino Meridian, according to official Plat thereof, a portion of Rancho Los Penasquitos according to Map accompanying the Patent in said Rancho recorded in the office of the County Recorder of San Diego County, in Book 2, Page 385 of Patents, and a portion of Pompeii Farms, Co., Pompeii Subdivision, according to Map thereof No. 1738, filed in the office of the County Recorder of San Diego County, all of said lands being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets, to wit: Alamazon Street and Andorra Way for public purposes and said streets are hereby declared to be public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said

Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
