

# RESOLUTION No. 203093

Adopted on JUL 6 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the construction of certain improvements on VEGA STREET, under the provisions of the Improvement Act of 1911, consisting of two sheets, and filed under Document No. 736456, is hereby granted.

That the engineering firm of WILLIAM S. KROOSKOS & ASSOCIATES be appointed to prepare plans, drawings, typical cross-sections, profiles and specifications for grading, paving and the installation of curbs, gutters and sidewalks on VEGA STREET, between Savannah Street and Weeks Avenue, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvements hereinabove mentioned.

That in the event the proposed Improvement Act proceedings fail to materialize or are abandoned before an assessment has been levied and collected, the City shall not be liable for payment of any of the costs incurred in said employment.
