Unit No. 6, filed June 25, 1971, in the office of the San Diego County Recorder, a drainage easement, the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, quitclaiming to THE OWNERS IN FEE SIMPLE OF RECORD of Lot 25, The Highlands, that certain easement for slope purposes affecting a portion of Lot 25, The Highlands, as more particularly set forth in that form of quitclaim deed, on file in the office of the City Clerk as Document No.
