Guy Maxwell	RECREATION DEPARTMENT	\$85	This is an additional award for savings made during the year following the initial award. The suggestion was for a device to be used with a fork-lift truck to handle heavy equipment so that a high rental charge for other equipment is eliminated.
Lanus B. Hill	PARKS & PUBLIC BUILDINGS Buildings & Facilities Div	\$30	Mr Hill suggested that a less expensive but entirely satisfactory grade of copper pipe be used for those jobs in which it is satisfactory. This has saved about \$300 in the first year that this has been done.
Bryan H. Hoopes, Jr.	FIRE DEPARTMENT	\$15	The use of a material called "Everclear" was proposed to prevent gas masks from fogging up in use. This may prevent both injuries from poor vision or smoke inhalation when masks are removed.
Jack Dickens	PUBLIC WORKS DEPARTMENT Equipment Division	\$10	A lifting device was designed for special handling of heavy packer tailgates. The previous chains used were subjected to excessive strain and were in danger of a hazardous break.
