APPROVING MAP OF PADRE GLEN SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by DON NASLAND, Licensed Land Surveyor, and entitled, "PADRE **GLEN** Being a subdivision of Acre Lot 150 of Morena, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 809, filed in the office of County Recorder of San Diego County, January 2, 1896, together with a portion of the Northerly 10 feet of Edison Street, adjoining said Acre Lot 150 on the South as said portion was vacated and closed to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Erie Street for public purposes, and said street is hereby declared to be public street and dedicated to the public use.

The said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The said Council rejects as a dedication for public street that portion of Lot 23 of this subdivision marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected on behalf of the public that portion of Lot 23 marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
