RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AWARDING A CONTRACT TO IMPROVE
AND TO ESTABLISH THE GRADE ON IVY STREET,
AND TO IMPROVE AND TO CHANGE THE GRADE ON
E STREET, F STREET, JEFFERSON STREET AND
OLD TOWN AVENUE.

office of the City Clerk.

award to be published twice in the City Official Newspaper and
to record notice of this award in the office of the County
Recorder as provided in Section 5248 of the Streets and Highways
Code.
