

WHEREAS, heretofore, by deed recorded April 1, 1940 in Book 1007, Page 303 of Official Records, in the office of the San Diego County Recorder, The City of San Diego acquired an easement for water pipeline purposes located in the Rancho Santa Fe area in the County of San Diego, which runs in a southerly and southwesterly direction from San Dieguito Reservoir to Lockwood Mesa; and

WHEREAS, the improvements that were served by said easement have been abandoned and said easement is not needed for any present or prospective City use; and

WHEREAS, said easement has not been used for a period of more than five (5) years and the City Manager has recommended that the City vacate its interest therein;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the water pipeline easement more particularly described hereinafter is hereby vacated:

All that certain easement for water pipeline purposes described as Parcel 26 in deed to The City of San Diego from San Diego Water Supply Company, a Nevada corporation, recorded on April 1, 1940 in Book 1007, Page 303 of Official Records and filed in the office of the City Clerk as Document No. 319058.

That from and after the date of this order of vacation, title to the land previously subject to said water pipeline easement shall revert to the owners of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder of said County of San Diego.
