That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a revised Agreement with the UNITED STATES OF AMERICA, acting by and through the Administrator of General Services, covering the exchange of real property in connection with the Federal Office Building Site, and closing portions of "E" street lying between Front and Union Streets and portions of Front Street lying between "E" and "F" Streets, under the terms and conditions set forth in the form of Agreement, on file in the office of the City Clerk as Document No. 736543.

That Resolution No. 201576, adopted December 31, 1970, be and the same is hereby rescinded.
