

RESOLUTION No. 203167

Adopted on JUL 13 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ALAN M. VOORHEES & ASSOCIATES, INC., a Delaware corporation, for the engineering design of three traffic signals with safety lighting, two of the installations to be on Sports Arena Boulevard and one on Midway Drive, all adjacent to the Fed Mart Shopping Plaza, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 736549.

2. That the offer from Fed Mart Corporation of the amount of \$36,300 towards the construction of the three traffic signals and safety lighting described above is hereby accepted.

3. That the expenditure of \$3,650 is hereby authorized out of Gas Tax Fund 219 solely and exclusively for the purpose of providing funds for the design, construction and related costs of the three traffic signals and safety lighting described above.
