

RESOLUTION NO. 203181 JUL 15 1971

APPROVING MAP OF MIRA MESA VERDE UNIT NO. 26 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM J. CLARKE, Licensed Land Surveyor, and entitled, "MIRA MESA VERDE UNIT NO. 26 Being a subdivision of a portion of the Northwest Quarter of the Southwest Quarter of Section 25, also a portion of the North Half of the Southeast Quarter of Section 26, of Township 14 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets and portion of public street, to wit: Acama Street, Acama Court, Tyrolean Road, Seawind Cove, Adriatic Place, Aqua Mansa Road, Batavia Circle, Batavia Road, Angeleno Road, Tyrolean Way, Berryknoll Street, Montongo Street, Seawind Lane and a portion of Branco Way for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Montongo Street adjacent and contiguous to Lots 2970 and 2971, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, the City of San Diego, a municipal corporation, hereby accepts the open space easement over Lots 3117 and 3102 granted on this map, subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council rejects as a dedication for public street Parcels "A" and "B" marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets and portion of public street are hereby accepted on behalf of the public as heretofore stated; and those certain

abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities, and the open space easement granted on this map, subject to the conditions set forth thereon; and said Council has rejected on behalf of the public Parcels "A" and "B" marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
