

RESOLUTION NO. 203247 JUL 27 1971

RESOLUTION CONSIDERING THE PROTESTS, AMENDING THE MAP, ORDERING THE DISTRICT FORMED, CONFIRMING THE ASSESSMENT AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1.

WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of San Diego Street Lighting Maintenance District No. 1 under Resolution of Intention No. 202986, adopted June 22, 1971, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The map, designated as San Diego Street Lighting Maintenance District No. 1, and consisting of 132 pages, on file in the office of the City Clerk as Document No. 736246, be amended by inserting those substitute pages, on file in the office of the City Clerk as Document No. 203247.
3. The District, the boundaries of which are described in said Resolution of Intention, is hereby ordered formed.
4. The assessments described in said Resolution of

Intention, and on file in the office of the Street Superintendent,  
are hereby confirmed and approved.

5. The maintenance described in said Resolution of  
Intention is hereby ordered performed.
