

RESOLUTION NO. 203249 ADOPTED JULY 27, 1971

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO,  
CALIFORNIA ORDERING ABANDONMENT OF PROCEEDINGS

(Dellcrest Assessment District)

WHEREAS, in proceedings pursuant to the Municipal Improvement Act of 1913 (commencing with Section 10000 of the Streets and Highways Code) the City Council adopted its resolution of intention, Resolution No. 202927, ordering the City Engineer to prepare his Report as required by said Act; and, pursuant thereto the City Engineer has prepared his Report, consisting of plans and specifications describing the proposed improvements, an estimate of the costs and expenses of said improvements, a diagram showing the assessment district and a proposed assessment of the costs and expenses of the proposed improvements, said Report being on file with the City Clerk, Document No. 736217; and

WHEREAS, the Council by Resolution No. 202928 approved the Report, as filed, and appointed a time and place of hearing thereon and also for a public hearing on the question whether the public convenience and necessity require such improvements and whether the Special Assessment Investigation, Limitation and Majority Protest Act of 1931 and the debt limitation and majority protest provisions thereof shall apply; and

WHEREAS, notices of the passage of Resolution Nos. 202927 and 202928 were duly published, posted and mailed, as provided by said act, and said hearings were duly held at the time and place so fixed, to wit, July 27, 1971, at the hour of 9:30 o'clock A.M. in the Council Chambers of the City Council; and

WHEREAS, the Council finds that written protests were made and filed against the proposed improvements by the owners of more than one-half of the area of the land to be assessed for the improvements, and that protests were not withdrawn so as to reduce the protest to less than a majority; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, as follows:

Section 1. The Council hereby orders that said proceedings shall be and the same are hereby abandoned.

Section 2. The City Clerk is authorized and directed forthwith to record a certified copy of this Resolution of Abandonment with the County Recorder of the County of San Diego in the form and manner as provided in Section 3117 of the Streets and Highways Code.
