2. That the bid of Commercial Envelope Company is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 600,000 PRINTED MAILING ENVELOPES at a cost of \$4.64 per thousand and 600,000 PRINTED RETURN ENVELOPES at a cost of \$3.59 per thousand for a total cost of \$4,938.00; terms 1% 10 days, plus sales tax.
