as follows:

Said Council hereby finds that that certain map surveyed by THOMAS E. CRAIG, Registered Civil Engineer, and entitled, "PENASQUITOS GLENS UNIT NO. 8 Being a subdivision of a portion of Section 33, Township 13 South, Range 2 West, San Bernardino Meridian, according to Official Plat thereof, and a portion of Rancho Los Penasquitos, according to Map accompanying the Patent in said Rancho recorded in the office of County Recorder of San Diego County in Book 2, Page 385 of Patents, including a portion of Pompeii Farms Co., Pompeii Subdivision, according to Map thereof No. 1738, filed in the office of County Recorder of San Diego County, all of said land being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.
