

RESOLUTION NO. 203267 JUL 27 1971

APPROVING MAP OF ROYAL PARK UNIT NO. 2 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, Licensed Land Surveyor, and entitled, "ROYAL PARK UNIT NO. 2 Being a subdivision of a portion of the Southwest Quarter of the Northeast Quarter of Section 26, Township 18 South, Range 2 West, San Bernardino Meridian in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved February 25, 1870.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public street and portions of public streets, to wit: Norstad Street, a portion of Arey Drive and a portion of Churrituck Drive for public purposes, and said street and portions of streets are hereby declared to be public street and portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
