

RESOLUTION NO. 203274

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to El Camino del Teatro, over and across a portion of Lot 17, Muirlands West Unit No. 1; and

WHEREAS, the owners of the property have requested that an exchange of abutter's rights be made to allow better utilization of the land; and

WHEREAS, it has been determined that the City Engineer has no objection to the exchange of said abutter's rights of access; and

WHEREAS, the value of the property rights to be exchanged are equal, as determined by a staff appraiser of said City, being the sum of \$50.00 each; and

WHEREAS, a fee of \$50.00 has been collected to cover the processing of this request; and

WHEREAS, it is in the public interest that said exchange be made, and the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and

on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 736739, to THE OWNERS IN FEE SIMPLE OF RECORD of Lot 17, Muirlands West Unit No. 1, effecting the revestment of those abutter's rights of access to El Camino del Teatro of said Lot 17, Muirlands West Unit No. 1, heretofore relinquished to the City, more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Mayor of said City for execution and transmittal to the Property Director of said City for recordation.
