

RESOLUTION NO. 203286

WHEREAS, the National League of Cities and the United States Conference of Mayors have obtained a Mass Transportation Grant under the Urban Mass Transportation Act of 1964, as amended, through the joint cooperative effort of the United States Department of Transportation and the President's Council on Youth Opportunity; and

WHEREAS, it is the purpose of the aforementioned grant to provide transportation support to the 50 cities having Mayor's Councils and Summer Youth Programs; and

WHEREAS, San Diego's Summer Youth Program, through the San Diego Mayor's Council on Youth Opportunity, has been offered a grant of \$14,360 by the National League of Cities and the United States Conference of Mayors; and

WHEREAS, as it is necessary to file a statement of acceptance and designate the City Auditor as the authorized agent to receive and disburse funds under the grant; and

WHEREAS, upon acceptance, operating responsibility for obtaining needed transportation services will rest with the City Manager and the Mayor's Youth Coordinator; and

WHEREAS, The City of San Diego is desirous of participating in the National League of Cities and the United States Conference of Mayors' project to finance special transportation services in connection with the San Diego Mayor's Council on Youth Opportunity's Project Summertime; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to accept the offer of \$14,360 from the National League of Cities and the United States Conference of Mayors and to execute the Summer Youth Transportation agreement in accordance with the provisions set forth in the agreement on file in the office of the City Clerk as Document No. 736755.

BE IT FURTHER RESOLVED, that the City Auditor is hereby designated as the agent authorized to receive and disburse funds received under the aforementioned Mass Transportation Grant.
