

RESOLUTION NO. 203287 JUL 27 1971

WHEREAS, The City of San Diego desires to undertake the development of a Command and Control System Project to be funded in part from funds made available through the Omnibus Crime Control and Safe Streets Act of 1968, administered by the California Council on Criminal Justice; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the California Council on Criminal Justice accepting grant funds in the amount of \$971,820, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 736721.


BE IT FURTHER RESOLVED, that the City agrees to provide required matching funds for said Municipal Command and Control System as specified within said above form of agreement.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.

BE IT FURTHER RESOLVED, that \$309,576 from Capital Outlay Fund 245, \$77,544 from Water Revenue Fund 502, and \$25,648 from Sewer Revenue Fund 506 be transferred

to the Command and Control System Phase II Fund 2707 to
provide that portion of the matching funds to be furnished
in cash.
