

RESOLUTION NO. 203295 JUL 29 1971

RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REQUESTING THE ECONOMIC DEVELOPMENT
ADMINISTRATION TO DESIGNATE PORTIONS OF THE
CITY OF SAN DIEGO AS A SPECIAL IMPACT AREA.

WHEREAS, under the provisions of Section 401(a)(6)
of the Public Works and Economic Development Act of 1965,
as amended, the Secretary is authorized to designate
Special Impact areas; and

WHEREAS, the Economic Development Administration
Planning Directive Number 52 - Chapter III of June 18,
1970, provides the policy and direction for such designation
by submission of an Overall Economic Development Plan; and

WHEREAS, the impact area has a population of over
81% minorities and an unemployment rate estimated to be
over 15% in contrast to a County average of 6.2%; and

WHEREAS, The City of San Diego is attempting to alleviate
economic dependency and chronic unemployment by developing
the economic potential in order to provide employment
opportunities; and

WHEREAS, The City of San Diego has developed an
Overall Economic Development Plan for the impacted area;
and


WHEREAS, The City of San Diego is applying for
designation of the impacted area as a Special Impact Area
in order to obtain assistance in carrying out the Overall
Economic Development Plan; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego
as follows:

That the City Manager be and he is hereby authorized to submit the San Diego Overall Economic Development Plan to the Economic Development Administration of the United States Department of Commerce.

BE IT FURTHER RESOLVED, that the Economic Development Administration of the Department of Commerce be and hereby is requested to consider and designate the impacted area as a Special Impact Area under the provisions of Section 401(a)(6) of the Public Works and Economic Development Act of 1965, as amended.
