2. That the expenditure of \$50,000.00 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego soley and exclusively for the purpose of providing funds for CONSTRUCTION OF MESA VERDE PARK, including Additive Alternate "A" in the City of San Diego, and related costs.
