LUEDTKE, Registered Civil Engineer, and entitled, "PACIFICA HILLS UNIT NO. 7 Being a subdivision of a portion of NW 1/4 of Section 26, Township 18 South, Range 2 West, San Bernardino Meridian in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved February 25, 1870, and portions of Beyer Way and Picador Boulevard as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street and portions of public streets, to wit: Beyer Way, portion of Picador Boulevard and portion of Via Tonga, for public purposes, and said street and portions of streets are hereby declared to be public street and portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portions of public streets are accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
