

RESOLUTION No. 203313

Adopted on JUL 29 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of UNITED STATES OF AMERICA, executed in favor of The City of San Diego, bearing date September 24, 1970, conveying to said City an easement and right of way for street purposes through, over and across portions of Lots 7, 21 and 32 and roads thereon of Rosedale Tract, according to Map thereof No. 825, filed in the Office of the Recorder of San Diego County, on January 21, 1897, together with easements for slope, general utility and sewer purposes, as more particularly described in said deed, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named TIERRASANTA BOULEVARD.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
