

RESOLUTION NO. 203324 AUG 3 1971

WHEREAS, RALPH O. SUIT, dba SIGHTSEEING SAN DIEGO, INC., has applied to the City Council for a Certificate of Public Convenience and Necessity to operate automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(a) There is a demand of the public for automobiles for hire of the type proposed in the application of Ralph O. Suit, dba Sightseeing San Diego, Inc.;

(b) Existing public transportation is inadequate for the accomplishment of the purposes stated in the application;

(c) The applicant is financially responsible and experienced;

(d) The equipment applicant proposes to use in the performance of the services proposed in the application consists of two Dodge 1968 Minibus & Flexible 1962 Recliners with capacity of 19 and 45 persons, respectively;

(e) The additional service for automobile for hire posed by applicant will not result in any greater traffic congestion or hazard to the public; and

WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That RALPH O. SUIT, dba SIGHTSEEING SAN DIEGO, INC.,
252 Kolmar, La Jolla, California, having filed an application
for a Certificate of Public Convenience and Necessity to
operate two vehicles for hire pursuant to the provisions of
Section 72.11 of the San Diego Municipal Code, and the City
Manager having conducted the required investigation, a
Certificate of Public Convenience and Necessity is hereby
granted to RALPH O. SUIT, dba SIGHTSEEING SAN DIEGO, INC.
to operate the vehicles specified in the application subject
to compliance with all provisions of the San Diego Municipal
Code, limiting said operation to sightseeing purposes only
and exclusively precluding charter operations.
