

RESOLUTION No. 203328

Adopted on AUG 3 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Stanley Andrews Sport Goods Co. 2. Crosthwaite Athletic Supply 3. Fournier Athletic Co, Inc. 4. Bill Smith Sporting Goods 5. Spartan Sales & Service Co. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of FIFTY-THREE (53) ITEMS OF MISCELLANEOUS ATHLETIC SUPPLIES for a period of one year beginning July 21, 1971 through July 20, 1972 per prices on file in the Purchasing Department as follows:

1. Stanley Andrews Sport Goods Co. for Items 7, 8, 21, 31, 32, 33, 35, 49, and 50; terms 2% 30 days plus sales tax, subject to escalation not to exceed 5% of bid prices;
2. Crosthwaite Athletic Supply for Items 3, 26, 36, 38, 39, 41, 42, 44, and 53; terms 2% 21 days plus sales tax, subject to escalation not to exceed percentage of cost increase from manufacturer or supplier. Vort and McGregor prices will remain firm for term of bid;
3. Fournier Athletic Co., Inc. for Items 1, 6, 29, 43, and 46; terms 2% 30 days plus sales tax, prices are firm;
4. Bill Smith Sporting Goods for Items 4, 5, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 22, 23, 25, 27, 28, 30, 37, 40, 45, 47, 48, 51, and 52; terms 2% 30 days plus sales tax, prices are firm;
5. Spartan Sales & Service Co. for Items 2, 20, 24, and 34; terms net 30 days plus sales tax, subject to escalation not to exceed 5% of bid prices.
