That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with CHICANO FEDERATION, INC., a nonprofit California corporation, to provide funds for professional services to assist in the initial development of the "Cultural de Raza" in Building No. 671 located in Balboa Park, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 736813.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer \$2,400 from Unallocated Reserve (53.30) to Special Recreation Programs (22.13) to provide funds for the professional services described above.
