

RESOLUTION NO. 203357 AUG 5 1971

WHEREAS, City Council Policy 600-7 requires that public hearings to consider revisions of the General Plan shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, on April 29, 1971, the Council of The City of San Diego adopted the ELLIOTT COMMUNITY PLAN, Document No. 735773, excluding therefrom the property which lies within Sound Intensity Zone 2, and also adopted an amended General Plan Map, Document No. 735774, in order to retain consistency between said plans; and

WHEREAS, the Council held an additional hearing on August 5, 1971, concerning that area of the Elliott Community Plan and the General Plan Map within Sound Intensity Zone 2; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The Council hereby adopts that amended General Plan Map entitled, "Progress Guide and General Plan for the City of San Diego," which includes the area within Sound Intensity Zone 2, a copy of which amended General Plan Map is on file in the office of the City Clerk as Document No. 736915.
