

RESOLUTION NO. 203408 AUG 12 1971

APPROVING MAP OF BAY TERRACES UNIT NO. 9 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by RICHARD T. STANDISH, Registered Civil Engineer, and entitled, "BAY TERRACES UNIT NO. 9 Being a subdivision of portions of Quarter Sections 50, 54, 55, 76 and 77 of the Rancho De La Nacion, in the City of San Diego, County of San Diego, State of California, according to the Map thereof No. 166, filed in the office of County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Alsacia Street, Barney Street, Brairwood Road, Dock Court, Doti Point Drive, Dylan Street, Fowler Drive, Latrobe Circle, Honey Drive, Jamie Avenue, Knott Street, Leighton Court, Leyte Point Drive, May Court and Woodman Street, for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

The said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Woodman Street, adjacent and contiguous to Lots 816, through 823, 911, 912, 923 through 926, 938 through 944 and in


and to Briarwood Road, adjacent and contiguous to Lots 993 through 996, all as granted and shown on said map.

The said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
