BE IT FURTHER RESOLVED, that 60TH STREET, between Federal Boulevard and State Highway 94,

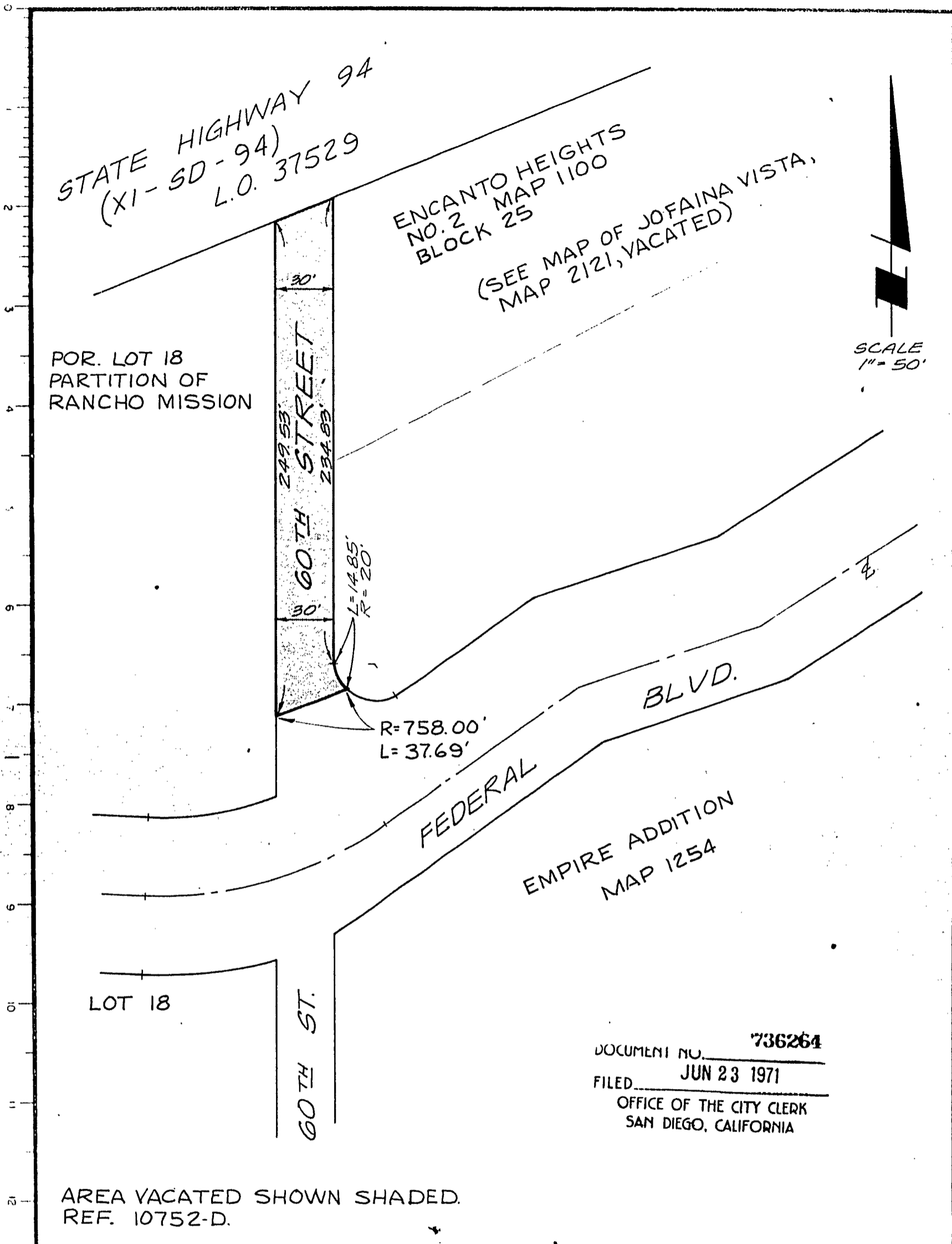
