

RESOLUTION NO. 203419 AUG 12 1971

APPROVING MAP OF ENCANTO INDUSTRIAL PARK SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by STANLEY ROGERS, Licensed Land Surveyor, and entitled, "ENCANTO INDUSTRIAL PARK Being a subdivision of a portion of Block 25 and a portion of vacated 60th Street (formerly known as Detroit Street), all of Tract No. 2 of Encanto Heights, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1100, filed in the office of the Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portions of a public street, to wit: portions of Federal Boulevard, for public purposes and said portions of street are hereby declared to be portions of a public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as

granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of a public street are accepted on behalf of the public as heretofore stated; and that the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
