RIHA, an unmarried man, as to an undivided one-half interest, and JAMES C. GILCHRIEST, a married man, as to an undivided one-half interest, as tenants in common, a portion of 60th Street, as vacated by Resolution No. 203417, adopted AUG 12 1971, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
