APPROVING MAP OF GENESEE HIGHLANDS UNIT NO. 2 SUBDIVISION.

Said Council hereby finds that that certain map surveyed by RICHARD T. STANDISH, Registered Civil Engineer, and entitled, "GENESEE HIGHLANDS UNIT NO. 2 Being a subdivision of portions of Pueblo Lots 1293 and 1302 and of those unnumbered Pueblo Lots of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Map thereof made by James Pascoe in 1870, a copy of which map was filed in the office of the County Recorder of San Diego County and is known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Cargill Avenue and Decoro Street, for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain easements, shown on Sheet 2, and the abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.
