

RESOLUTION NO. 203465 AUG 17 1971

WHEREAS, heretofore, a certain railroad easement was reserved by The City of San Diego in Fed-Mart Industrial Park, according to Map thereof No. 6785, filed November 17, 1970, in the office of the San Diego County Recorder; and

WHEREAS, said easement was reserved to install and maintain trackage to serve the Fed-Mart property; and

WHEREAS, the Atchison, Topeka and Santa Fe Railway Company, a Delaware corporation, is now ready to construct said trackage and will construct and maintain the railroad within the easement; and

WHEREAS, said easement should now be quitclaimed to the Atchison, Topeka and Santa Fe Railway Company and the City Manager has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed quitclaiming to the ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY, a Delaware corporation, an easement for railroad purposes over and across a portion of Fed-Mart Industrial Park, according to Map thereof No. 6785, filed November 17, 1970, in the office of the San Diego County Recorder, as more particularly described in the form of quitclaim deed, on


