

RESOLUTION NO. 203466

WHEREAS, by Resolution No. 202284, adopted March 30, 1971, the City accepted an easement in a portion of the Northeast Quarter of the Northwest Quarter of Section 35, Township 18 South, Range 2 West, S.B.B.&M. from Dale Building Company, a corporation; and

WHEREAS, the description of said easement was erroneous; and

WHEREAS, said Resolution No. 202284 should be rescinded; and

WHEREAS, a deed correctly describing the easement has been received and will be presented for Council acceptance; and

WHEREAS, said erroneous deed has heretofore been recorded, and it is now necessary, in order to clear any cloud that might have been created by said recordation, for the City Council to authorize the execution of a quitclaim deed of any interest that the City might have acquired by said erroneous deed; and

WHEREAS, the City Manager recommends that said quitclaim deed be executed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution No. 202284, adopted by the Council of The City of San Diego on March 30, 1971, be, and the same is hereby rescinded.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, that certain quit-claim deed, the form of which is on file in the office of the City Clerk as Document No. 737017.

3. That the City Clerk be, and he is hereby directed to deliver said deed, together with a certified copy of this resolution, to the Mayor for execution and transmittal to the Property Director for recordation.
