WHEREAS, Section 6466, Streets and Highways Code of the State of California provides that Section 53460, et seq. Government Code of the State of California, shall apply in connection with lost or destroyed bonds; and

WHEREAS, Morley H. Golden has provided a Bond for Securities Lost or Destroyed No. 8495755, issued by the Fidelity and Deposit Company of Maryland, holding The City of San Diego harmless in the amount of \$654.41; and

WHEREAS, this Council is satisfied by competent proof that 1911 Act Improvement Bond No. 17, Series 3142 of The City of San Diego has been lost; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer is hereby authorized to issue a new 1911 Act Improvement Bond No. 17, Series 3142, to replace that lost, misplaced or stolen.

BE IT FURTHER RESOLVED, that the City Treasurer place in his files the affidavit of Morley H. Golden attesting to the loss and the indemnity agreement of Fidelity and Deposit Company of Maryland.
