APPROVING MAP OF FRIARS VILLAGE UNIT NO. 2 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "FRIARS VILLAGE UNIT NO. 2 Being a subdivision of a portion of Lot 2 of Monterey Club, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6591, filed in the office of the County Recorder of San Diego County February 20, 1970 and a portion of Pueblo Lot 1103 of the Pueblo Lands of San Diego, in said City, according to Map thereof made by James Pascoe in 1870, known as Miscellaneous Map No. 36 filed in the office of said County Recorder, November 14, 1921.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Via Las Cumbres adjacent and contiguous to Lots 163-A, 164-A and 167-A, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation,

the easements granted in paragraphs 1, 2 and 3 in the Owners' Certificate, and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that those certain abutters' rights of access, together with the easements, all as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
