

RESOLUTION NO. 203500

WHEREAS, comprehensive planning for urban development is needed on a continuing basis and is consistent with national policy as expressed in Section 701 of the Housing Act of 1954, as amended; and

WHEREAS, comprehensive transportation planning within the City of San Diego must be accomplished jointly with the California Division of Highways; and

WHEREAS, the California Division of Highways requires that each small area and other special transportation study conducted jointly with local agencies be covered by a separate agreement outlining the responsibilities of each party; and

WHEREAS, The City of San Diego desires to participate in such joint transportation planning studies on a continuing basis; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and is hereby authorized and empowered to execute for and on behalf of said City joint transportation planning agreements with the Division of Highways, Department of Public Works, State of California, providing for feasibility and economic analyses, assembly of data, the processing and analysis of data by computer and other techniques, and formulation of conclusions and recommendations for transportation development.

BE IT FURTHER RESOLVED, that whenever a proposed agreement requires the payment of City funds to the State of California in order to carry out a cooperative study, the expenditure of such funds shall be specifically authorized by the Council prior to the execution of such agreement.
