

RESOLUTION NO. 203501

AUG 19 1971

WHEREAS, Senate Bill No. 503, currently pending in the California Legislature, seeks to increase the State resident adult fishing license fees from \$3 to \$4 a year and hunting license fees from \$4 to \$6 per year, as well as various other fee increases including deer tag fees and fishing stamps; and

WHEREAS, the revenues from these increases are to be used for the operation of the State Department of Fish and Game; and


WHEREAS, the Department receives no money from the general fund of the State of California and has not been granted a fishing and hunting license fee increase since 1957, even though the cost of enforcement of fish and game regulations throughout the State of California has risen markedly; and

WHEREAS, The City of San Diego derives substantial benefit from funding and operation of the Department of Fish and Game through various programs, including a trout stocking program at San Vicente Reservoir and the enforcement of "Look But Don't Touch" regulations within the San Diego-La Jolla Underwater Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council hereby endorses the provisions of

Senate Bill No. 503 providing for an increase in State
resident adult fishing license fees from \$3 to \$4 a year
and hunting license fees from \$4 to \$6 per year, and various
other fee increases including deer tag fees and fishing
stamps.
