

RESOLUTION NO. 203504 AUG 24 1971

RESOLUTION OF THE COUNCIL OF THE
CITY OF SAN DIEGO, CALIFORNIA, MAKING
FINDINGS AND OVERRULING PROTESTS AND
OBJECTIONS, ORDERING CERTAIN CHANGES AND
CONFIRMING A SUPPLEMENTAL DIAGRAM AND
SUPPLEMENTAL ASSESSMENT.

(Centre City Way Assessment District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council heretofore adopted Resolution No. 201560 ordering certain improvements and the formation of Centre City Way Assessment District; and

WHEREAS, the Council adopted Resolution No. 203234 proposing to order certain changes in the improvements and the extent of the assessment district, fixed a time and place of hearing on the question of the changes, and approved a Supplemental Report, prepared by the City Engineer, containing plans and specifications for the proposed additional work, an estimate of the costs and expenses of the additional work, a map showing the proposed modification in the boundaries of the assessment district by the inclusion of additional territory therein, a proposed supplemental diagram showing said additional territory and the dimensions of lots, parcels and subdivisions of land therein, and a proposed supplemental assessment of the total amount of the costs and expenses of the proposed additional work remaining after deducting the amount of the contribution to be made by the city; and

WHEREAS, certain owners of property within the additional territory proposed to be included in the assessment district have heretofore filed a request for said changes with the City Clerk and have deposited with the city the total amount proposed to be assessed upon such owners' property; and

WHEREAS, said Resolution No. 203234 has been duly published, as required by law, and the hearing provided for therein has been duly held, and all interested persons desiring to be heard have been fully heard and all oral and written protests and objections, if any, have been fully heard and this Council gave all persons present an opportunity to hear and be heard in respect to the changes, the Supplemental Report, the supplemental diagram and supplemental assessment, the proposed additional improvements and the plans and specifications therefor, and the boundaries of the additional territory proposed to be included in the assessment district or in any way relating to the Supplemental Report and the changes proposed by said Resolution No. 203234; and

WHEREAS, the Council has received evidence relating to the Supplemental Report, the proposed additional improvements, the boundaries of the additional territory proposed to be included in the assessment district, the supplemental diagram and supplemental assessment and the benefits to the property within the additional territory proposed to be included in the assessment district; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego as follows:


Section 1. The Council hereby orders that the additional improvements described in Resolution No. 203234 and in the Supplemental Report be made and further orders that the additional territory described in Resolution No. 203234 and in the Supplemental Report be included in the assessment district. Reference is hereby made to Resolution No. 203234

and said Supplemental Report for a full and complete description of the additional improvements, the additional territory included within the assessment district and for further particulars.

Section 2. Each and all oral and written protests, if any, made or filed in the matter of the proposed changes are hereby overruled and denied.

Section 3. The supplemental diagram and the supplemental assessment, as contained in said Supplemental Report, are hereby confirmed.
