WHEREAS, Assembly Bill No. 3050 creates the San Diego Regional Council of Governments (SANCOG) providing for the adoption of a regional plan and for a successor to the San Diego Comprehensive Planning Organization; and

WHEREAS, this Council on June 17, 1971, by Resolution
No. 202943 endorsed AB3050 as it was written on that date; and
WHEREAS, several amendments to AB3050 were introduced
on the floor of the Assembly on August 9, 1971; and

WHEREAS, it is the consensus of the Council that additional study of AB3050 is required; and

WHEREAS, the Council would like to commend the San Diego Comprehensive Planning Organization and the California Legis-lature for their efforts expended on the development of AB3050; (SANCOG); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. The City Council of The City of San Diego requests the California State Legislature, through the appropriate committee, to subject AB3050 to a serious interim study between the time of the adjournment of the 1971 session of the Legislature and the commencement of the 1972 legislative session.
- 2. That the Council recommends that said interim hearings on AB3050 be held in the San Diego area thereby providing all interested agencies and individuals an opportunity to testify

on AB3050 as amended on August 9, 1971.

3. That the Comprehensive Planning Organization and the California Legislature be commended for their efforts expended in the development of AB3050 (SANCOG).
